Re: Expanded Peanut and Peanut Related Product Recall - URGENT

In response to the ongoing investigations of Peanut Corporation of America (PCA) and its Texas facility, Wells' Dairy, Inc., is expanding its recall and response to include a recall of select Blue Bunny® ice cream products. These products may contain peanuts from the PCA Texas facility.

Wells' Dairy will continue to monitor this matter, provide additional direction and information as it becomes available, and take any and all expanded action as may be necessary.

PCA is no longer a supplier of any product for Wells' Dairy, and all product orders from this date forward, including for those listed below, will contain peanuts and peanut based products from approved manufacturers, none of which will be associated or affiliated with PCA.

The expanded product recall includes **SELECT PRODUCTS WITH "BEST USED BY" DATES PRIOR TO 2/4/2010 (ALL LOT NUMBERS) AND SELECT BULK ITEMS WITH JULIAN CODE 9035 AND PRIOR (for example 9034, 9033, 9032...). JULIAN CODE IS LOCATED ON OUTSIDE OF SHIPPING CONTAINER.**
