Re: Recall Notice:
SunOpta Grains and Foods, Inc recalls approximately 2,000 cases of limited code dates of *Planters* 3 oz Sunflower Kernels with BEST BY Dates of 03 06 17*, 03 07 17* and 03 08 17* distributed only in the U.S.

SunOpta Grains and Foods, Inc. is recalling limited code dates of *Planters* 3 oz Sunflower Kernels, that they manufactured, because of the potential to be contaminated with *Listeria monocytogenes*.

The recall is limited to approximately 2,000 cases of 3 oz packages of *Planters* Sunflower Kernels with BEST BY Dates of 03 06 17* , 03 07 17* and 03 08 17*.

No other sizes, varieties or code dates of *Planters* nuts or seeds are included in this recall.

There have been no consumer complaints to date or reports of illness.
