Re: Expanded Recall Notice:
SunOpta Grains and Foods, Inc. recalls approximately 20,000 additional cases of limited code dates of *Planters* 3 oz Sunflower Kernels with BEST BY Dates between 10/17/16 - 12/28/16* and 01/23/17 - 02/08/17* distributed only in the U.S.

SunOpta Grains and Foods, Inc. is expanding its recall of limited code dates of *Planters* 3 oz Sunflower Kernels, which they manufactured, because of the potential to be contaminated with *Listeria monocytogenes*.

The expanded recall is limited to approximately 20,000 additional cases of 3 oz packages of *Planters* Sunflower Kernels with BEST BY Dates between 10/17/16 - 12/28/16* and 01/23/17 - 02/08/17*.

Recent previous recalls included approximately 4,000 cases of 3 oz packages of *Planters* Sunflower Kernels with BEST BY Dates of 03 06 17*, 03 07 17*, 03 08 17*, 03 13 17*, 03 14 17*, 03 15 17*, 03 16 17*.

No other sizes, varieties or code dates of *Planters* nuts or seeds are included in this expanded recall.

There have been two reported consumer complaints of illness associated with the recalled product.
