

## **Product Recall - Notification to Customers**

## Gold Medal and Pillsbury Hotel & Restaurant Flour and Gold Medal Wondra

July 1, 2016– General Mills announced today an expansion to the May 31<sup>st</sup>, 2016 recall involving **Gold Medal Flour, Pillsbury Flour and Gold Medal Wondra** due to the potential presence of E. coli O121. The recall is being expanded due to a newly reported illness that appears to have stemmed from the consumption of raw dough or batter linked to flour produced last fall.

- 3. Please direct your operators or retailers to destroy the affected packages and submit a detailed credit request to your servicing distributor. Once completed, please submit an invoice to your General Mills Customer Service Representative for reimbursement for all destroyed flour product specifically related to this recall from your warehouse and the operators or retailers you have credited.
- 4. If the operators you service have finished product made with the recalled flour or product out of their control, they should work with their local FDA office to determine the appropriate next steps.
